Vision: To instill passionate curiosity & a deeper understanding of the world around us.

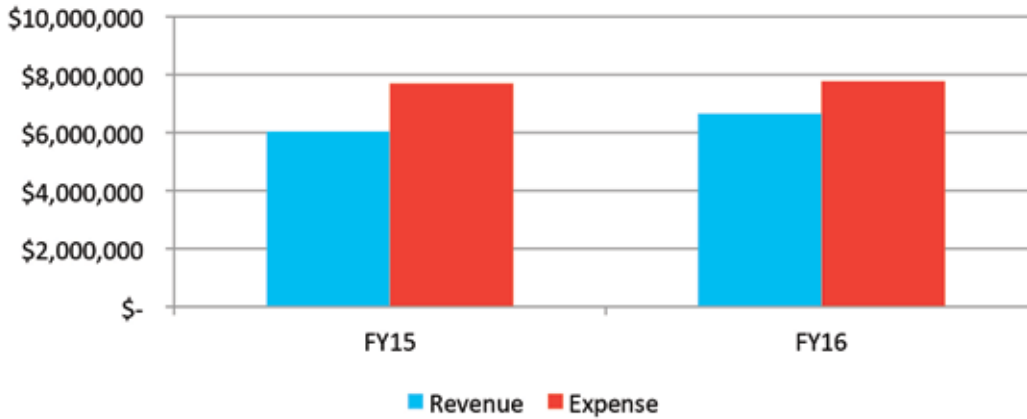

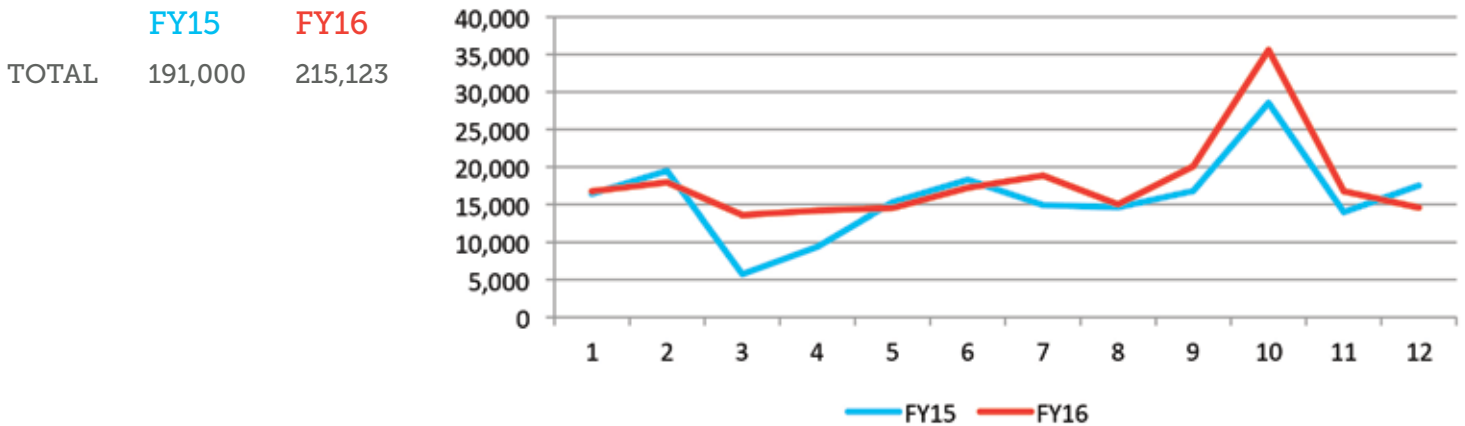
Fiscal Year 2015 and 2016 Revenue and Expenses
